WARRANTY

(1) Amway* warrants that the GLISTER[™] MULTI-ACTION POWER TOOTHBRUSH will not prove defective (as defined below), under normal use for two (2) years from the date of original purchase. An item will be considered "defective" if it is defective in materials or workmanship and if the defect materially impairs the performance or value of the device to the original purchaser (the "Purchaser").

2. Exclusions

This Warranty does not cover:

(a) Device that has been subjected to any use that is different from, or inconsistent with, the instructions for use.

(b) Device that has been subjected to any abuse, accident, physical damage, misuse, alterations or neglect.

3. Device that has not been subjected to abuse, accident, physical damage, misuse, alterations, neglect proves to have been defective during the warranty period, Amway will, at Purchaser's option and subject to timely notification of the claimed defect replace the defective item at its expense, or refund an appropriate part of the price of the item to the Purchaser.

4. Claim

In order to make a claim under this Warranty, the Purchaser must notify Amway of the defect, in writing, within 1 month after the defect has been discovered, but in all events no later than 1 month after the end of the applicable warranty period.

The Purchaser must provide proof of purchase, i.e., the invoice for the devise or other proof of purchase.

5. Limitations

This Warranty will not be valid if a third party has materially altered the item to repair it.

Unless otherwise required under European Union and national laws, this Warranty sets forth the Purchaser's sole and exclusive remedies for any defect in the devise.
